Nana Akua Anyidoho is a Senior Research Fellow at the Institute of Statistical, Social and Economic Research (ISSER) at the University of Ghana and is co-convener of the Young People and Agri-Food theme of the Future Agricultures Consortium. Nana Akua has a PhD in Human Development and Social Policy from Northwestern University. She is interested in the intersection of policy processes with the everyday lives of people. Her recent research focuses on the pathways of economic empowerment for young people; the career aspirations of university students; and the informalisation of women's work.
