Notes on Contributors

Andrew Challinor was a founding member of the cross-disciplinary Crops and Climate Group at the University of Reading where, in collaboration with colleagues, he pioneered a new approach to the simulation of the response of crops to climate. Contracts and grants from the Department for Environment, Food and Rural Affairs (DEFRA), the Natural Environment Research Council (NERC), the British Council and the European Union have allowed him to explore the impacts of climate variability and change on crops in India, Africa and China. In May 2007, Andrew began a Lectureship at the University of Leeds, where he continues to work on the knowledge base that strengthens the food security of populations vulnerable to climate variability and global environmental change.

Fiona Ching is currently working with the Hong Kong Red Cross focusing on community-based disaster risk reduction and organisational development of the Indonesian Red Cross (PMI). She previously worked with the International Federation of Red Cross and Red Crescent Societies in Jakarta on urban slum disaster risk reduction and climate change adaptation. She conducted participatory video activities in two flood-prone communities in Jakarta, together with the PMI and Red Cross/Red Crescent Climate Centre.

Mark Davies is Manager of the Centre for Social Protection at the Institute of Development Studies (IDS), having previously worked with the UK Department for International Development (DFID) in Africa and London as a livelihoods adviser. He has practical and research experience working in social protection, food security, livelihoods, poverty and vulnerability. He has worked extensively in Ghana, Kenya and Malawi, working within bilateral agencies, multilateral organisations and in close partnership with governments and NGOs. Mark has in-depth knowledge of the policies, institutions and processes that influence both social protection policy and programming.

Justina Demetriades is a research and communications officer for BRIDGE, a gender and development programme at IDS. Her research interests include gender and security, including personal security. She is Manager and Editor of the BRIDGE Cutting Edge Pack on Gender and Climate Change (forthcoming) and is also managing the BRIDGE Gender and Governance Cutting Edge Pack. She co-authored a report for DFID on Gender and Climate Change:

Mapping the Linkages (BRIDGE 2008) and managed and edited Gender and Indicators (BRIDGE 2007). In 2007, Justina undertook field research on the information communication dynamics around gender issues for the IDS Strategic Learning Initiative.

Bina Desai is a rural sociologist and social anthropologist with a particular interest in international agriculture, climate change adaptation and disaster risk reduction. For the last ten years she has studied and worked primarily in East and West Africa, and South Asia, and more recently held policy and advocacy positions in the UK and Europe. Bina holds a PhD from the School of Oriental and African Studies and currently works as Senior Policy and Research Officer with Christian Aid (UK) on disaster risk reduction across Central America, Southern Africa, and South and South-east Asia.

David Dodman is a researcher in the Human Settlements and Climate Change Groups at the International Institute for Environment and Development (IIED). He holds a DPhil in Geography from the University of Oxford and was previously a lecturer in Geography at the University of the West Indies (UWI), Mona, Jamaica. His work has been published in academic journals including Area, Cities and the Geographical Journal, and he is co-editor (with Duncan McGregor and David Barker) of Global Change and Caribbean Vulnerability: Environment, Economy and Society at Risk (UWI Press, forthcoming).

Frank Ellis is Professor at the School of Development Studies, University of East Anglia. He

specialises in the livelihoods approach to poverty reduction in low-income countries, focusing on the assets and activities of rural households; and the income and wellbeing outcomes they achieve — within risk and institutional contexts. This approach is fundamental to contemporary policy engagement with chronically poor and vulnerable groups, including understanding poverty traps and thresholds, and policy choices concerning effective forms of social protection. Frank has a current research focus on social protection in Africa and is co-authoring a book on this for publication in 2009.

Emily Esplen is a research and communications officer for BRIDGE, a gender and development research and information programme based at IDS. Her research interests include gender and sexual and reproductive health and rights, and men and masculinities. She recently co-authored and edited a report for DFID on Gender and Climate Change: Mapping the Linkages (BRIDGE 2008). Other publications include Women's Economic Empowerment: Putting Gender Back in the Picture (with Alyson Brody, BRIDGE 2008); Politicising Masculinities: Beyond the Personal (with Alan Greig, IDS 2008); and the Gender and Care Cutting Edge Pack (BRIDGE, forthcoming).

Martin Greeley is a development economist with over 30 years of professional experience including ten years of long-term overseas work (Andhra Pradesh, India, Sri Lanka and Bangladesh). His main areas of interest are: aid and public policy, agricultural development, impact assessment, poverty reduction, and microfinance. Richard Matthew is Associate Professor of International and Environmental Politics in the Schools of Social Ecology and Social Science at the University of California at Irvine, and founding Director of the Center for Unconventional Security Affairs (CUSA). He has a BA from McGill and a PhD from Princeton. He studies the environmental dimensions of conflict and post-conflict reconstruction and has done extensive fieldwork in conflict zones in South Asia and East Africa. He is also a member of the United Nations Expert Advisory Group on Environment, Conflict and Peacebuilding and the Senior Fellow at the International Institute for Sustainable Development (IISD) in Geneva.
