## **Notes on Contributors**

Renato Athias is Professor of Anthropology and Coordinator of the Centre for the Study of Ethnicity at the Federal University of Pernambuco, Brazil. He has written extensively on traditional curative practices and health, particularly with reference to the Hup'däh people of the Rio Negro region in the northwest Amazon, and edited publications on mythology and indigenous medicine with traditional practitioners in the region. He is a board member of the Brazilian non-governmental organisation (NGO) Associação Saúde Sem Limites, and an adviser to NGOs, bilateral development agencies and the Brazilian Government.

Ali Cheema is Associate Professor of Economics and Head of the Economics Department at Lahore University of Management Sciences. A Rhodes Scholar, he holds a PhD in Economics from the University of Cambridge and an MPhil in Economics and Politics from the University of Cambridge. He coconvenes the Initiative of Policy Dialogue's 'Taskforce on Decentralization' at Columbia University and is co-convenor of the State Capacity programme, funded by the IDS Development Research Centre (DRC) on the Future State. His areas of research are political economy, public choice, development economics, economic history, governance and decentralisation, with a strong policy focus.

**Diana Conyers** is a Research Officer in the IDS Governance Team. She is primarily engaged in teaching on the MA in Governance and Development programme. She has many years' practical experience of decentralisation in sub-Saharan Africa, especially in Tanzania, Zambia, Zimbabwe and Uganda, and has written extensively on the subject.
